ii. Syarikat yang terlibat perlu mengemukakan permohonan melalui Sistem Covid 19 Intelligent Management System (CIMS) 3.0 Kementerian Perdagangan Antarabangsa dan Industri (MITI) atau mendapat kelulusan Kementerian Pengangkutan Malaysia (MOT) untuk beroperasi;

ii. *Company involved are required to submit applications through the Covid-19 Intelligent Management System (CIMS) 3.0 operated by Ministry of International Trade and Industry (MITI) or must have permission given by Ministry of Transport (MOT) to operate;*

iii. Syarikat hanya dibenarkan beroperasi dengan kapasiti pekerja berdasarkan peratusan (%) pekerja yang telah lengkap menerima vaksin seperti berikut:

iii. *Company are only permitted to operate at the capacity based on the percentage (%) of employee who have completed vaccination as follows:*

iv. Mematuhi protokol kesihatan yang ditetapkan oleh Kementerian Kesihatan Malaysia (KKM) dan pelaksanaan norma baru seperti pemeriksaan suhu badan, mengimbas MySejahtera, penjarakan fizikal, menyediakan dan menggunakan cecair pembasmi kuman tangan dan memakai pelitup muka;

iv. *Comply with health protocols as stipulated by the Ministry of Health (MOH) and implementing of new norms such as checking body temperature, checking in MySejahtera, maintain physical distancing, provide and use hand sanitizer and wearing face masks;*

v. Pekerja yang bergejala, sedang dalam kawasan Perintah Kawalan Pergerakan Diperketatkan (PKPD), individu di dalam pemerhatian (PUS) dan sedang dalam kuarantin adalah tidak dibenarkan hadir bekerja.

v. *Employee with symptoms, under Enhanced Movement Control Order (PKPD) area, Persons Under Surveillance (PUS) and persons under quarantine are not allowed to work.*
