**SUBJECT** : **COMPLIANCE ON THE USE OF  
AUTOMATIC IDENTIFICATION SYSTEM  
(AIS) BY SHIPS WITHIN TANJUNG  
PELEPAS PORT LIMIT**

Your attention is kindly referred to the above matter and to JPA's Port Notice No. 7/7/2010 dated 31 May 2010.

2. As the port regulatory authority, Johor Port Authority places high emphasis to the safety and security of the port and its surrounding waters. All ships are required to follow to all rules and regulations relating to the safety and security on board ships and at ports.

3. The requirements for the installation of safety equipment on board ships are under the Safety of Life at Sea (SOLAS) Convention, Chapter V, Regulation 19- Carriage Requirement for Ship borne Navigation Systems and Equipment.

4. Under the International Ship and Port Facility Security Code (ISPS Code), Chapter 3 – Application, Ship Security Alert System shall apply to the following types of ship that are engaged in international voyages:

- i. Passenger ships, including high- speed passenger craft;
- ii. Cargo ships, including high – speed craft, of 500 gross tonnage and upwards; and
- iii. Mobile offshore drilling units

5. With regards to the above, and with effect from **1 MAY 2013** it shall be **MANDATORY** for all ships required to be equipped with AIS under SOLAS, and every ship that is required to comply with the ISPS Code to switch on the AIS equipment on board at all times when entering or within the Tg.Pelepas Port limit. This shall include rivers, all piers, all jetties, wharves, landing places, quays, docks, anchorage area, laid up area until the ship sails out of Tg.Pelepas Port.

Adalah dengan hormatnya merujuk kepada perkara di atas

2. Selaku badan kawal selia Pelabuhan, Lembaga Pelabuhan Johor sentiasa memberi perhatian tinggi kepada keselamatan dan sekuriti pelabuhan serta perairannya. Oleh itu semua kapal-kapal hendaklah mematuhi semua perundangan dan peraturan berhubung keselamatan dan sekuriti di atas kapal dan di pelabuhan.

3. Keperluan pemasangan peralatan keselamatan di atas kapal terdapat di bawah Konvensyen *Safety of Life at Sea (SOLAS)*, Bab V, Peraturan 19-*Carriage Requirements for Ship borne Navigational Systems and Equipment*.

4. Di bawah *International Ship and Port Facility Security Code (ISPS Code)*, Bab 3 – *Application, Ship Security Alert System* hendaklah dipatuhi oleh semua kapal yang melalui laluan antarabangsa seperti berikut:

- i. Kapal penumpang termasuk kapal penumpang berkelajuan tinggi
- ii. Kapal kargo termasuk kapal berkelajuan tinggi (500GT dan ke atas)
- iii. *Mobile Offshore Drilling Unit (MODU)*

5. Sehubungan dengan di atas, berkuatkuasa **1 MEI 2013**, setiap kapal **DIWAJIBKAN** memasang sistem AIS berdasarkan keperluan SOLAS dan setiap kapal yang dikehendaki mematuhi Kod ISPS dengan ini diarah untuk wajib sentiasa memasang AIS semasa memasuki atau berada di dalam kawasan Pelabuhan Tanjung Pelepas. Ini termasuk di sungai-sungai, dermaga-dermaga, terminal, jeti persendirian, kawasan labuhan, kawasan labuh tunggu dan disemua kawasan sehinggalah kapal selamat belayar keluar dari had Pelabuhan Tanjung Pelepas.

6. Kerjasama semua pihak dikehendaki untuk mematuhi arahan Notis Pelabuhan ini. Tindakan sewajarnya akan diambil terhadap kapal-kapal yang gagal berbuat demikian.
